**AMENDED SCHEDULING ORDER FOR CRIMINAL TRIAL WEEK BEGINNING
SEPTEMBER 8, 2025**

An Amended Scheduling Order was issued on October 28, 2024 scheduling Judge NeSmith's September 8, 2025 trial week. That Order is hereby AMENDED to modify the dates for which the parties must be present and to add additional defendants as follows:

IT IS HEREBY ORDERED THAT:

The cases set forth on Exhibit "A" attached hereto shall constitute the Trial Calendar for the week of September 8, 2025, subject only to any jail cases and cases in which statutory speedy trial demands have been filed.

A CALENDAR CALL will be held the 26th day of June, 2025, at 9:30 A.M. in the Courtroom of the OGLETHOPRE COUNTY COURTHOUSE, OGLETHORPE SUPERIOR COURT, 111 WEST MAIN STREET, LEXINGTON, GEORGIA 30648. You are required by law to be present. **It shall be the responsibility and obligation of the moving party to cause a Rule Nisi to issue for the hearing on any pending Motion(s) or Plea(s) for July 24, 2025, or August 26, 2025. All parties must be present August 26, 2025 for the final trial calendar review.** Any pending Motion(s) or Plea(s) not scheduled and brought for hearing on said date, absent good cause shown, shall be considered abandoned. All parties shall be ready to proceed to trial in the Superior Court of Oglethorpe County the week beginning September 8, 2025.

YOU HAVE THE RIGHT TO BE REPRESENTED BY AN ATTORNEY. YOU MAY BE ELIGIBLE FOR THE APPOINTMENT OF AN ATTORNEY TO REPRESENT YOU, IF YOU ARE INDIGENT. TO DETERMINE YOUR STATUS, YOU MAY CONTACT THE NORTHERN JUDICIAL CIRCUIT PUBLIC DEFENDER'S OFFICE AT (706) 246-9320.

All Defendants and Counsel must be present on August 26, 2025 at 9:30 A.M. for a Status Conference if your case has not been disposed of or has otherwise been excused by the Court. Parties will be notified via email with the cases that need to report before August 26, 2025. **This date will be your last opportunity to enter a plea prior to trial on September 8, 2025.**

The Clerk of Superior Court shall send a copy of this Order and Exhibit to all Defendants, bondsmen, and attorneys.


